MESSAGE FROM THE MANAGEMENT

The past year, 2003, passed in a relatively stable political situation (still slow, but consistent implementation of the Framework Agreement provisions).

The negative economic trends from the previous year were not stopped, and the announced and partially started reforms (solution for loss making companies; decrease of over-employment in public enterprises and the public administration) significantly increased the social tensions (general strikes were announced for the beginning of 2004).

Despite the declarations of the Government for greater co-operation with NGOs, there were few initiatives and examples of co-operation. On the other hand, the Government adopted the "Action Plan for Implementing the Recommendations of the Stabilisation and Association Report of the European Commission for the Republic of Macedonia - 2003". The plan contained a separate part with specific measures and activities that referred to the development of the civic society and the instigation of the role of the local NGOs, such as; changes in the Law on Citizen Associations and Foundations; introduction of tax alleviations for citizen associations and foundations; adoption of a strategy for development of the civic society; adoption of a programme for co-operation with NGOs; establishment of an office for co-operation with NGOs of the Government of RM; establishment of NGO support centre.

In 2003, MCIC completed its third mid-term period (2001-2003). In the past year, MCIC also celebrated its 10th anniversary.

In 2003, MCIC had a total scope (portfolio) of 144 projects and a total budget of approximately 140 million

MCIC had the expected progress in its regular programmes: VSZ, OZI, POR, JZN, (started in the previous years). Several new programmes were started: SLD, GKG, GSV, SMR, PRL, PRM, JPK; FSI and SCR were intensified, while the following programmes were completed: PJN (started in 2000), TKS and MGK (started at the end of 2001). Part of the planned programmes (PGO and JSN) were implemented to a lesser extent, and MRI was cancelled. In this period, MEDF started the implementation of the new 2002-2005Strategic Plan, with four new programmes: PFU, NFU, PSR, PRP.

Novelties in the work of MCIC are: the division of the former PJN programme into four new ones, the start of the pilot-programme (PRM) for work with the churches and the religious communities in Macedonia, as well as a programme aimed at inter-ethnic tolerance (Pages of Mutual Understanding - SMR).

In this period, MCIC conducted the procedure for election of an executive director, which ended at the beginning of June with the re-election of Saso Klekovski at this post.

MCIC continued its intensive regional cooperation through the initiatives of WCC, such as the capacity building hub, ACT and APRODEV, and, throughout the past year, has joined the work of the World Social Forum, MCIC also joined other initiatives, such as IRENE of UN, for establishing an informal regional NGO network.





WATER SUPPLY AND SANITATION

WATER SUPPLY AND SANITATION OF COMMUNITIES (VSZ)

The goal of the programme is to provide access to drinking water and drainage of waste waters.

The target group of the programme includes inhabitants from the communities in Macedonia, with a specific focus on the regions that have significant problems in water supply and sanitation.

Within the 19 approved projects in 2003, 22 village communities were covered, inhabited by 18,463 citizens. According to the ethnic breakdown, most of them or 44,72% were Macedonians, followed by 36,38% ethnic Albanians, 16,69% Turks, 1,07% Serbs, 0,70% Roma and 0,44% Vlachs.

In the course of 2003, 19 projects were approved for construction, completion or reconstruction of: four pump stations, two connections to regional water supply systems, one catchment, 503 m³ of tank space (4 tanks), 40,960 m' of pipeline, one filter for water purification, construction of one waste water purification plant and rehabilitation of an existing purification plant.

The total value of the 19 approved projects, without the operation expenses, amounted to MKD 82,978,300. MCIC participated with MKD 48,962,013, or approximately 60%.

HEALTHY DRINKING WATER FOR 140 PEOPLE FROM ZABRCANI

The village of Zabrcani, in the municipality of Dolneni, has finally obtained healthy drinking water. The satisfaction of the villagers of Zabrcani was even greater because the village board, that is, the villagers themselves with the help of the municipality and in co-operation with AMPEP (an NGO financed by the Swedish SIDA) managed to complete nearly 50% of the planned works for construction of the water supply system.

"We have lived here ever since. Most of the households in the village are on social welfare. I used to work in the city, in Prilep. We have always had problems with the water. The village has always mainly worked in agriculture, so now I also work in agriculture, I plant tobacco, and I have cattle... There are ten of us living in my house", we were told by Zivko Risteski, inhabitant of the village.

"The last 10 years have been very dry. The wells went dry, and we went to get water in the neighbouring villages, in Senokos, Dolneni, and even Prilep. Until 1996 they would bring us water in tanks, but that delivery was stopped, as well", added Zivko.

With the construction of the water supply system, 140 villagers, or 50 households of Zabrcani provided a long term solution to the water supply problem.

So far, the population mainly used the water of the two village wells, where the water was bacteriologically polluted

The project implemented by MCIC completed the already started water supply system, i.e. a pump station was built, installation works were conducted on the pressure pipeline, and the return pipeline and the secondary water supply network were completed.

The village and the municipality participated with their financial means and labour on the ground works of the pressure pipeline, as well as on providing the energy inflow for the work of the pump station.







LABOUR EVENTUALLY PAYS OFF

The village of Arnakija is part of the municipality of Saraj, Skopje region. The villagers have been lacking water during the summer period for quite some years now. At the moment, they use water from several individual local wells, despite the fact that the usage of the water had been forbidden due to chemical and bacteriological pollution.

"The initiative to build the waterworks started two years ago. The municipality could not implement this project because of the difficult economic situation. The villagers together with the municipality contributed to the preparation of the project and to applying at various institutions. In the period June-September, around 80 families remain without water. The villagers bring water from the school using their donkeys and barrels", Haxhbi Zendeli told us, a member of the initiative board for construction of the water supply system.

The villagers from Arnakija used to work in agriculture, but the number has decreased in recent years due to small profits. Most of the villagers are nowadays employed in the public enterprises or have relatives living abroad.

The construction of the water supply system will resolve the problem with the water for 160 families.

The constructed water supply system will be connected to the city water supply system of Skopje near the village of Ljubin, which is expected to provide sufficient quantities of healthy drinking water for the villagers.

"All our troubles with the various documents and our search for possible investors paid off in the end. We will all get water and our children will be healthier". Haxhi Zendeli told us as we were about to leave.

The construction of the water supply system was enabled by a donation of MCIC, the municipality of Saraj and the self-contribution of the citizens of Saraj.

ENABLING COMMUNITIES AND INSTITUTIONS (OZI)

The goal of the programme is to enable communities and institutions to organise and manage development initiatives. This goal reflects the strategy for solving the institutional problems of the communities and institutions, which directly provides sustainable development.

Target group of the programme are: the citizens of the communities in Macedonia, with a specific focus on the regions with significant problems with water supply and sanitation.

In 2003, a total of 98 participants from the communities and citizen associations were covered within the organised trainings, workshops, advice and consultations for preparations, organisation and implementation of projects.

For the first time this year, MCIC supported the participation of ten municipalities at the Fair of Municipalities organised by ZELS. The project provided for exchange of experiences between the municipalities and improved informing of the public and other actors about the work of the municipalities.

In 2003, financial support was provided to three village communities for pre-project activities, and five public communal enterprises were supported with technical and office equipment.

HOW TO APPROACH DONORS

"My organisation managed to successfully get in touch with a foreign donor organisation present in the country. We then managed to convince them to install central heating system at the 'Aleksandar Zdravkovski' primary school in Jegunovce. We received great help in the preparation of the project proposal by the mayor of our municipality", stated Conka Grozdanovska from the Women Association of the Municipality of Jegunovce. For her, this is the first seminar on "approach the donors"

Stojan Lazarov, mayor of the municipality of Konce and one of the participants in the seminar, stressed at the end of the training. "This is my first time at a training of this kind. Now I can see the shortcomings of my previous experiences. The seminar provided me with greater self-confidence and additional knowledge. I will share this experience with the employees at the municipality."

The goal of the training was to develop the capacities of the leaders' groups of the communities, in order to provide for strengthening of local development initiatives. The participants obtained knowledge on: establishing the first contact with the donor; manner of communication; submitting a project proposal; implementing and reporting; and, communication after the completion of the project.

HEALTH AND EDUCATION

APPLIED EDUCATION FOR YOUNG ROMA (POR)

The goal of the programme is to improve the involvement in primary education and increase the possibilities for employment of Roma youth, through: raising the awareness of children and families in Roma communities on the importance of education; improving the relations between local primary schools and the local Roma communities; improving the business qualifications and skills of young people in Roma communities; and, improving the informing of the public and the public institutions about educational and other problems of the Roma.

The target group of the programme included young Roma at 11 to 25 years of age. Regarding the vocational training courses and apprenticeship, there was also the possibility for young people until 30 years of age to be included. The programme also covered the broader Roma community, personnel of the involved primary schools, non-Roma pupils, as well as the wider public and public institutions.

The Applied Education for Young Roma programme was implemented in 15 Roma communities in 11 towns in Macedonia, in co-operation with 15 local primary schools. In the academic 2002/03 year, a total of 20,198 pupils attended the involved schools, 3,330 of whom were Roma (or 16% of the total number of pupils in the 15 schools). In the academic 2003/04, there were a total of 16,184 students attending the schools, 3,454 of whom were Roma (or 21% of the total number of pupils).

Within the programme and in the course of 2003, 22 projects were implemented, 19 of which provided financial support to projects of the local partner organisations and covered activities for strengthening the awareness on education in the Roma communities, activities for building relations between the schools and commu-

nities, and activities for improving the qualifications of the Roma youth. A summer camp for 75 children from the involved schools was organised, as well as an inter-school quiz-competition, where again children from all involved schools participated.

Within the lobbying and advocacy activities, the celebration of the 8th of April - World Roma Day was organised in co-operation with a group of Roma and other NGOs under the motto "We are all one". In the course of June, MCIC supported the national conference "The Situation of Roma in Macedonia", where representatives of public institutions and the civic sector participated, discussing possible solutions for improvement of the situation of the Roma.

DRUG HELPLINE (SLD)

The goal of the programme is to train social workers and psychologists who will obtain and use in practice knowledge and skills for providing clear and understandable information, on the danger of use and abuse of drugs and prevention from HIV. The goal was planned to be achieved through establishing and providing the functioning of the Drug Helpline, realisation of preventive activities (information and advice related to drugs and AIDS protection) and through strengthening the capacities of the programme partners.

Target group of the programme are the citizens of the Republic of Macedonia who have the need of information for the use and abuse of drugs and dangers and possible protection from AIDS, potential drug users (especially high school youth) and drug users. The programme covers the whole territory of Macedonia, with a part of the activities focussing on the Stip region, where the Inter-Municipal Centre for Social Work of Stip (MCSR - Stip), one of the partners in the programme, is located.

The programme covered: 24 graduated social workers who received training for working on the Drug

Helpline; 12 pedagogues, psychologists and professors from the six high schools in Stip, who received training in drugs and drug use and abuse related consequences; 347 citizens who called the Drug Helpline, 70 students from 6 high schools in Stip who participated in preventive workshops; and, 14 members/employees of the partner organisations who participated at the training for institutional development/organisational strengthening.

EMPLOYMENT AND INCOME GENERATION

MCIC is the founder and representative of the Macedonian Enterprise Development Foundation (MEDF).

MEDF implemented the planned activities from its Strategic Plan through four programmes: Programme for Financial Services (PFU), Programme for Non-financial Services (NFU), Programme for Subsector Development (PSR) and Programme for Platform for Small and Medium Enterprise Development (PRP).

NON-FINANCIAL SERVICES (NFU)

The goal of the programme is capacity building of the actors in the Micro and Small Enterprises (MSE) sector. The tasks of the programme are: to enhance access to financial services for individual farmers. self-employed and entrepreneurs from MSE; help the creation of appropriate environment for development of micro and small businesses, and ensure sustainability of these services at all levels.

Four financial intermediaries, 53 associations and 10 consultants, i.e. consultancy companies were supported in 2003. There were a total of 683 participants in the organised trainings.

FINANCIAL SERVICES (PFU)

The goal of the programme is to improve the access to financial services through: improvement of the access to financial services for farmers, selfemployed and entrepreneurs from MSE; promotion of services that are feasible and replicable in the private sector; mobilising and acquiring financial means in the country and abroad for financial and non-financial services, thus ensuring the sustainability of these services at all levels.

In September 2003, four financial intermediaries were accredited: Tutunska banka AD Skopje, IK banka AD Skopje, Stopanska banka AD Bitola and the saving house Moznosti. Framework financial agreements were signed with them.

Three loans of the Loan type 1 were distributed. The loans were intended for individual farmers, entrepreneurs and self-employed persons, and amounted to a total of 77,000 Euro, covering 12 final beneficiaries.

The Loan type 2 supported 43 small enterprises in an amount of 1,603,474 Euro.

The Loan type 3 was paid in a total amount of 1,115,696 Euro in 9 instalments (7 through Moznosti and 2 through IK banka), thus supporting a total of 198 final beneficiaries.

SIGNED FRAMEWORK FINANCIAL AGREEMENTS BETWEEN MEDF AND THE ACCREDITED FINANCIAL INSTITUTIONS

On 12 September 2003, MEDF signed the framework financial agreements for implementation of the credit line with the selected financial institutions: Tutunska banka AD Skopje, IK banka AD Skopje, Stopanska banka AD Bitola and the Moznosti saving house.

When signing the agreements, Saso Klekovski, the representative of MEDF stated: "After four years of experience with Tutunska banka and the saving house Moznosti and the expansion of the activities enabled by the Netherlands government, today, we also make agreements with two new banks: IK banka and Stopanska banka AD Bitola. MEDF opted for the concept of strengthening existing financial institutions, as opposed to supporting the establishment of a new institution, because of the expectations that this would provide greater contribution to reaching our goal improving the services for micro and small enterprises."

In this phase, support will be offered to develop the credit capacity of the branches and offices outside Skopje, which should foster the regional approach. It is expected that the total amount of the paid credits would not only include assets from MEDF, but also own capital of the banks, thus multiplying the effect of

> the foreign aid through mobilisation of domestic funds.

With the adoption of the 2002-2006 Strategic Plan of MEDF and the signing of the agreement for its financing with the Government of the Kingdom of the Netherlands, the loan fund of MEDF increased for additional 4.9 million Euros and it is expected to reach an amount of approximately 9 million Euros at the end of 2005. In order to provide for capacity building of its target group, besides the loans, MEDF also provides non-financial services.

PLATFORM OF THE CIVIC ORGANISATIONS IN MACEDONIA (PGO)

The goal of the programme is to establish a mechanism that will contribute to an improved enabling environment for the civic organisations, through initiating and establishment of a participative civic platform in Macedonia, encouraging the communication, co-ordination and co-operation among the civic organisations and encouraging the co-operation of the civic organisations with the public, government, donors and the business sector.

Target group of the programme are the civic organisations in Macedonia, the public, media, public sector, private sector and the international organisations and agencies.

NGO FAIR - THIRD FORUM OF CIVIC SOCIETY IN MACEDONIA

In order to contribute to the strengthening of the institutional capacity of civic organisations in the country, this year's NGO Fair - 3rd Forum of the Civic Society in Macedonia widely opened its doors for all visitors who came to the Skopje Fair in the period 20-22 November. More than 10,000 citizens visited the exhibition part where 205 civic organisations from all sectors were presented at 135 stands, with the Sector for European Integration of the Government of the Republic of Macedonia and the religious communities of Macedonia present for the first time. Organisations from Serbia and Montenegro, Kosovo, Slovenia, Bosnia and Herzegovina, Denmark, Georgia, Kazakhstan, Kyrgyzstan and Russia also participated at the Fair.

The number of forum activities was increased compared to the year before: 48 panels, forums, round tables, educational sessions were organised. Only four of the forum events were organised by the Fair organisers; all other events were organised by the participants themselves.

The Fair was organised by MCIC,in the cooperation with the Foundation Open Society Institute Macedonia (FOSIM) and the Institute for Sustainable Communities (ISC).

CAPACITY BUILDING OF CIVIC ORGANISATIONS (GKG)

The goal of the programme is to strengthen the organisational capacity of civic organisations in Macedonia, in order to enable further development of the civic society through improved functioning of civic associations. Therefore conditions will be provided for capacity building of civic organisations through training and consultancy, and through transfer of knowledge and skills to civic organisations that would influence their more efficient and more effective work.

Target group of the programme are civic organisations in the Republic of Macedonia.

The programme covered a total of 252 participants in training, 196 of whom participated in the standard courses, 56 in the tailor-made courses and 8 volunteers received the "on-job" training.

ADVANCED PUBLIC RELATIONS COURSE

How can we show the results of our work to the public? How do we explain our goals and tasks? How do we bring the effects of our work closer to the citizens? These and many other questions we face every day and we try to respond in the best possible way that we know of. The course was directed towards transfer of knowledge and skills for building and maintaining relations with the public through media, both electronic and printed, and through organisational ways and forms (brochures, bulletins, reports, presentations, etc).

Valentina Saurek, head of the judiciary department at the Ministry of Justice and one of the participants in the training, said: "Public relations are an issue I deal with every time we organise conferences, seminars, when we foreign visitors, donors, etc. This is my first time to be at a training of this kind. I can say that I have the possibility to improve my knowledge here. This would be useful in many cases, such as in the communication with the journalists. They often ask

sensitive questions, and the same thing can happen with foreign diplomats, and it is good to know how to answer in a calm manner at that moment."

There were 16 representatives of civic organisations, government institutions, and the business sector participating at the course.







MCIC started publishing its new publication called "Civic Practices", which is a result of the search for our own "domestic" understanding of the civic society. The search for local concepts and practices of the civic society emerged from the awareness that citizen organizations and initiatives are effective only if they are local owned and are rooted into the society. "Civic Practices" should stimulate and support the building of local concepts and practices of the civic society in Macedonia. Two editions with two main themes were published: "100 Years of Macedonian Statehood - Citizen Initiatives in That Period" and "Civic Education - Has It Achieved Its Goal."

STRENGTHENING WOMEN NGOS (JZN)

The goal of the programme is to develop skills and knowledge at the women associations for application of the concept of gender equality in the communities through development, promotion and implementation of initiatives adequate for their target group.

Target group of the programme are women from rural and suburban areas, with a special accent upon different ethnic minorities.

The training and thematic workshops covered nine activists of women NGOs employed at the organisations, 15 local trainers trained in the concepts of gender equality, methods and techniques of participatory training implementation, 258 participants at the local training for gender equality, delivered by the local trainers, 108 participants (both men and women) at the six thematic workshops for gender equality on various topics. Around 800 NGOs, government institutions and individuals were covered with the distribution of the Perspectives magazine.

STRENGTHENING STRATEGIC CIVIC ORGANISATIONS (JSN)

The goal of the programme is strengthening the organisational capacities of the strategic civic organisations in RM, which would strengthen their influence and make significant changes in the sector where they are active and broader. The programme should contribute to building an effective civic society.

Target group of the programme are civic organisations from Macedonia that will be of strategic importance for the development of the civic society in Macedonia in the future.

The programme covered 5 organisations: Polio Plus - Post Polio Support Group, Skopje; PADS Megjasi, Skopje; Movement of the Ecologists of Macedonia, Skopje; Association of Women Organisations of Macedonia, Skopje; and, the Association for Democratic Initiatives, Gostivar.

ADVISORY CENTERS FOR CITIZENS(SCR)

The goal of the programme is improved information and strengthened awareness of the citizens for implementation of their rights in order to create an objective basis for influencing the government.

Target group of the programme are the marginalised groups who live on the territory of the Republic of Macedonia and who have no appropriate access to information for protection of their civic rights.

Six advisory centres were established within the programme: in Gostivar, Kumanovo, Stip, Prilep, Delcevo and Skopje. The basic activities of the advisory centres for the citizens in this period were: presentation of the programme to the target group and the relevant insti-

tutions; collection and distribution of information about civic rights; assistance to individuals in obtaining their personal documents (citizenship, ID, various certificates, such as newly-born registration certificates); assistance to individuals in completing the documents for health or social welfare aid; filling in individual applications for unemployment benefit, social welfare, health protection; individual registration with the unemployment bureaus, etc.

118 persons addressed the centres after their establishment, with various requests for advice or legal assistance. Within the programme, there were three trainings held: training for human rights protection; PCM and ID/OS, where 14 beneficiaries were covered (personnel or activists or the centres).

Promotion/informative materials were printed at the opening of the advisory centres. The circulation of the leaflets is 500 copies in each advisory centre, which were distributed to the local self-government and the target population. The first issue of the "Monitor" bulletin was published in November.





CIVIC SOCIETY AND DEMOCRACY

The goal of the programme is to improve the information of the public about inter-ethnic relations in Macedonia and to influence the media to inform on

inter-ethnic relations in an objective and comprehensive way.

Target group of the programme are the public and journalists, i.e. the media.

The SMR programme is prepared and fully implemented in co-operation with the partner organisation Association of the Journalists of Macedonia (ZNM), Macedonian Information Agency (MIA) and the five newspapers: Dnevnik, Utrinski vesnik, Fakti, Vecer and Lobi

The first "joint page" entitled "However" was published on 14 August 2003. By the end of the year, "However" was published for 21 times. The page is published every Thursday in the five newspapers, as well as on the web page of MIA. A round table entitled "Disarmament and the Journalist Informing" was also held.

SUPPORT TO IDPS (PRL)

The goal is to contribute to the process of stabilisation of the regions affected by the 2001 conflict, as well as to support the IDPs in their efforts to resolve their situation, by protecting their rights, supporting social activities, strengthening their associations and researching their needs and possible solutions to the problems.

Target group are the IDPs from the villages affected by the conflict, who still do not have or who think that they do not have conditions for return to their homes. The focus is on the IDPs in the collective centres.

MCIC continued the support of the three associations of IDPs in 2003, as well. A joint office was opened in Skopje and one person was hired full time. A lawyer was also hired, who started procedures for fulfilment of the rights of IDPs. Part of the support to IDPs (especially children) consisted of psycho-social activities, with regard to the trauma of the two-year stay in the collective centres. This included a seven-day stay

in a summer camp for 96 children from the collective centres and equipping an internet club in one of the collective centres. At the end of the year, an evaluation study on the situation was conducted. The mission included analysis of the existing documents and reports, interviews with relevant actors, field visits, and workshops.

CROSS-SECTORAL PROGRAMS

AWARDS FOR CIVIC SOCIETY AND DEMOCRACY (GOD) AND FOR SUSTAIN-ABLE DEVELOPMENT "GERT JAN VAN APELDOORN" (GJA)

The goal of the awards is to support citizens and organisations that provide a special contribution to local and national initiatives for the development of civic society and democracy, i.e. towards sustainable development in Macedonia.

The target groups are organisations, groups and communities, as well as individuals who are active in the civic sector.

This year, the Award for Civic Society and Democracy was awarded to: A1 Television for their long-term contribution; Macedonian Women Lobby, for the achievements in the previous year, and the associations Natyra and Zora for their transparency and co-operation, respectively.

Boge Cadinovski received the Gert Jan van Apeldoorn award for long-term contribution, and AD Alkaloid for achievements in the previous year.





STRENGTHENING OF KOSOVO PARTNERS (JPK)

The goal of the programme is to strengthen the institutional capacity of the local partners for a more efficient implementation of the activities in the efforts for development of the civic society in Kosovo.

Target group are the beneficiaries of the services of the three local NGOs from Gjakovica, partners in the programme implementation: Kosovo Development Center, We Are with You, and the Kosovo Women Initiative.

The first projects in the capacity building component were approved last year and started with procedures for external financial audit of the accounts of the three partners for 2002, as a condition for continuation of the support. The capacity building plans included: training of personnel and management structures for strategic planning; PCM; organisational development; English language; human resources management; mobilisation of funds; study and exchange visits; and, development of procedures.

CAPACITY BUILDING NETWORK (MGK)

The goal of the programme is to strengthen the capacity of the ecumenical partners in South-East Europe in the sense of developing mutual co-operation.

The target group includes the partner NGOs from the region.

The programme, which had started in 2001, was ended this year. Several activities were implemented in 2003, such as: visit to the NGO Fair in Zagreb; training of partners; and publishing an Address Book of the Ecumenical Partners in South-East Europe. In December, in Novi Sad, the Third Meeting of the partners was used to define the principles of co-operation, the vision and mission of the network, as well as to obtain suggestions for specific activities, which were used in the formulation of the new programme.

MCIC 10[™] ANNIVERSARY

The Macedonian Center for International Co-operation was established on 14 December 1993. MCIC marked the 10th anniversary of its founding with the "I Live Here" campaign, an academy and a monograph. The academy took place at Holiday Inn (the former Grand Hotel, where the founding meeting took place in 1993). Around 700 guests were present at the event, among whom were Boris Trajkovski, President of RM, Liljana Popovska, Vice-President of the Parliament, and Radmila Sekerinska, Vice Prime Minister. A monograph was printed for the event entitled "10 Years of MCIC" in 2,000 copies in Macedonian. The monograph covered the most significant events in the course of the last ten years. It was distributed to around 800 addresses of citizen associations, media, business sector, state institutions, embassies, etc.

PERSONNEL

At the end of 2003, MCIC had 39 staff, i.e. there were 37.9 equivalents of full time workers in this period.

There were changes in the personnel in the past period: four employees left MCIC on their request (two from the Civic Society Department and one at the Employment Stimulation Department and one of the International Programme Group); five new employees were hired (one in the Employment Promotion Department, one in the Information Department, and three in the Cross-Sector and International Programmes Group); one employee was internally shifted (from the Emergency Operations Group to the Civic Society Department), and one was shifted as a replacement for an employee on a maternity leave.

Part of the employees attended tailor-made trainings on: Administrative Work, Project Cycle Management, Institutional Development and Organisational Strengthening. Individually, some of the employees attended the following training courses: Strengthening of Civic Society, Legal Regulations for the Annual Financial Report for 2002, Project Management and Programme Administration, Modern Technologies in the Computer Networks, Training of Trainers, Public Advocacy and Lobbying, SME Development in the Global Economy, Council of Europe in function of initiating legal changes in the issues related to the persons with handicap in RM and the region, DEKUS 6th Symposium, and Web Design for NGOs.

CO-OPERATION

MCIC had intensive co-operation with the local civic organisations and the units of the local self-government. Contacts were also established with the Government and other state institutions.

MCIC continued the co-operation with the World Council of Churches and the Consortium for Macedonia, as well as with ACT International.

The Consortium for Macedonia held its eighth meeting in Skopje in May. The organisations that participated at the meeting were ICCO, DCA, EED, CAID, NCA, WCC and MCIC. At the meeting, the socio-economic and political situation in the country and the annual report of MCIC for 2002 were discussed, as well as the plans of MCIC for the future period and further co-operation. The ninth meeting was held in November in Bonn, Germany (hosted by EED). Several bilateral meetings were held, too.

PUBLIC RELATIONS

MCIC Bulletin continued to be issued this year in Macedonian and English. MCIC issued two versions of the Annual report. The first one, on 20 pages, contained more comprehensive information on the work of MCIC and was intended for the target groups and the partners of the organisation. The second one, in a smaller format, contained the basic information on MCIC activities in 2002 and was intended for the public.

There were a total of 560 appearances in domestic and foreign media: 93 in electronic and 467 appearances in the printed media. From the printed media announcements, 416 were paid ads, and 144 were articles, short information, and interviews about the work of MCIC.

MOBILISATION OF RESOURCES

MCIC prepared several applications for funding. EAR approved the application for the two year Pages of Mutual Understanding programme; the application for the Bridging Religions in Macedonia programme was approved by DCA and NCA; the application for a one-year support for water supply to the Norwegian Church Aid (NCA) was approved; the applications to DCA for the programmes JSN 2003-2005 and PGO 2003-2004 were approved; the application sent to ICCO on the basic mid-term programme for 2004-2006 was approved; also were the application to EED for the programmes GKG, GSV and JSN 2004-2006.




He is also responsible for the internal financial control, for keeping the funds of MCIC and prevention and detection of abuse and other irregularities.
